

As a condition of using our services, the following Waiver & Assumption to Hold Harmless must be signed and paragraphs initialed:

By choosing to utilize the services, participate in activities at Let's Go Canine, Inc. I agree to the following:

- I agree to pay the rates for services that are in effect at the time my dog attend Let's Go Canine, Inc. I am aware that extra charges may be incurred and I agree to pay them at the time of pick-up. _____
- I understand that on entering Let's Go Canine, Inc. my pet will be examined for fleas. If fleas are found, immediate pick up of my dog will be required. I have read and acknowledge the admission policies pertaining to vaccinations that are required and "not required" for participation in Let's Go Canine, Inc. services. Further, I agree with the vaccination policies and agree I am responsible for the continuation of vaccinations and providing updated copies of such vaccinations annually as a requirement while participating in Let's Go Canine services. _____
- If my dog participates in playgroup, daycare, boarding, training or any other services, I understand that an interactive play setting is not without some risk of injury, that despite all the dogs appearing healthy and being handled with the greatest amount of care and foresight, dogs are not always predictable and the unexpected may occur. I recognize that interactive play with multiple sized dogs or dogs in general is not without risk of injury and assume the risk associated with the benefits of an interactive play. I agree to pay veterinary expenses incurred as a result of injury associated with interactive play. I further agree to pay for injuries or damages caused by my dog including but not limited to another dog or human. _____
- I understand that Let's Go Canine, Inc. will exercise all due diligence and care in the guardianship of my pet and contact me immediately if my dog is injured in an accident. If my pet appears to be ill / injured and needs emergency services, I authorize Let's Go Canine, Inc. to engage the services of a veterinarian at my expense, to give other requisite attention, and to make decisions required for my pet's veterinary treatment. I agree to pay all veterinary charges incurred by my pet while in the care of Let's Go Canine, Inc. I will not hold Let's Go Canine, Inc., its employees, owners, agents and subcontractors liable for the decisions made pertaining to the veterinary care of my dog or the judgment not to seek veterinary care or authorize veterinary care. I authorize Let's Go Canine, Inc. its employees, owners, agents and subcontractors to transport or provide care for my dog outside of Let's Go Canine, Inc. including but not limited to seek veterinary services, pick up and drop off or any unforeseen circumstance. _____
- I hereby waive and release Let's Go Canine, Inc. its employees, owners, agents and subcontractors from any and all liability of any nature, for injury or damage, including that which may result from the action of any dog including my own, and I expressly assume the risk of such damage or injury while my dog participates in or attends any function of Let's Go Canine, Inc. or subcontracted services, while on the grounds or the surrounding area thereto, including transportation of my canine. _____
- It is expressly agreed that use of Let's Go Canine, Inc. facilities and or services shall be undertaken by the undersigned or guest at his/her sole risk, and Let's Go Canine, Inc. shall not be liable for any injuries or any damage to the undersigned or guest, including the property of undersigned or guest, or be subject to any claim, demands, injury or damages whatsoever. The undersigned hereby expressly acknowledges that this Waiver applies to any minor who uses the facility or their guest. It is expressly agreed that Let's Go Canine, Inc. is not liable for articles damaged, lost or stolen in or about the Let's Go Canine, Inc. facilities or for loss or damages to any property, including, but not limited to, automobiles and the contents thereof. The undersigned acknowledges that the activities undertaken at Let's Go Canine, Inc. are inherently risky and possibly dangerous. _____
- I represent that my dog has never attacked or injured another dog or human and I have answered all questions accurately to the best of my knowledge on all applications, questionnaires required for the participation of services at Let's Go Canine, Inc. _____
- I agree that any photo's and video of my canine produced by let's Go Canine, Inc. during the course of any participating activity at let's Go Canine, Inc. or while participating in any event with Let's Go Canine, Inc. is the property of Let's Go Canine, Inc. I agree all content may be use without compensation or permission for any and all marketing and advertising including but not limited to video social media and or internet use. _____
- I agree not to enroll any dog(s) in Daycare that has any condition that could potentially jeopardize the health of other dogs or people and has not had any potentially communicable condition within 30 days prior to enrollment. I further acknowledge that though my dog is vaccinated for bordatella (Kennel Cough) there is a risk that my dog can still contract Kennel Cough. I agree NOT to hold Let's Go Canine responsible if my dog(s) contracts Kennel Cough. I acknowledge that the Kennel Cough vaccination is not a guarantee of immunity and in groups of dogs Kennel Cough is an assumed potential risk to my dog while participating in Let's Go Canine activities. _____
